# OUR COMMITMENT TO **EMERGENCY MANAGEMENT**

Effective emergency management starts with risk mitigation. Inter Pipeline invests heavily in training and preparedness with the goal of zero incidents.

CEP has a comprehensive emergency response plan (ERP) detailing roles and responsibilities, critical response procedures, public protection measures and emergency communication protocols. The plant conducts a broad range of emergency response drills and exercises every year to ensure we are always ready and prepared.

In the unlikely event of an emergency, early detection and response is vital. Our state-of the-art control centres and leak detection systems allow us to continuously monitor, remotely control and operate our systems, so that we can address any problems or anomalies in real-time.

# **OUR COCHRANE EXTRACTION PLANT**

The Cochrane Extraction Plant (CEP) plays a crucial role in Canada's energy infrastructure, safely and efficiently processing natural gas to produce valuable energy products that fuel the daily lives of millions of people across Canada and beyond.

CEP is one of the largest of its kind in Canada, with the capacity to process 2.5 billion cubic feet of natural gas per day. This allows us to recover approximately 100,000 barrels per day of natural gas liquids (NGL), including:

barrels per day of ethane used to manufacture the essentials of daily living

barrels per day of propane-plus, energy source for heating homes and fueling businesses and industry

As a key processing site on the western leg of the TC Energy Alberta System, the CEP supports local and national energy needs, ensuring responsible and sustainable energy development.

**History:** CEP has been a part of the Cochrane community since 1968. It takes about 60 employees to operate it 24 hours a day, 7 days a week.

**Product:** Gas processed at the plant is sales specification product from the TC Energy mainlines that is used to fuel our homes and industry. After Cochrane extracts the ethane and propane this gas makes its way down the Pacific Northwest to California.

**Capacity:** CEP can process enough natural gas in one day to supply 25,000 homes for a year.

Maintenance: CEP has one full-plant maintenance shutdown scheduled every five years. During these turnarounds there can be an increase in noise and local traffic. The next turnaround is expected to be in 2027.

**Environment:** White, cloudy vapors can sometimes be seen on top of CEP's cooling towers. These towers help remove heat from the water-cooling systems, and the cloud coming off them is water condensation only with no environmental impact.

All CEP emissions are monitored continuously and reported regularly in line with regulatory requirements. The plant operates well below Ambient Air Quality Objectives limits and any other applicable regulatory limits.
